OTHER SERVICES PROVIDED INCLUDE EDUCATING SCHOOL-AGED CHILDREN THROUGHOUT FRESNO COUNTY ON PET RESPONSIBILITY AND ANIMAL SAFETY. CCSPCA EDUCATION STAFF PROVIDES FREE PRESENTATIONS TO MORE THAN 30 SCHOOLS THAT REQUEST PROGRAMMING, INCLUDING DOG BITE PREVENTION, PET RESPONSIBILITY, ANIMAL CAREERS, SPAY/NEUTER AWARENESS, AND HOW TO HELP ANIMALS. THEY OFFER MULTIPLE EDUCATIONAL OPPORTUNITIES SUCH AS TOURING CLASSES, SPECIAL MEETING PRESENTATIONS, SAFETY CLASSES FOR PROFESSIONALS, CREATIVE EVENTS, SERVICE LEARNING PROJECTS, AND MANY OTHER SPECIAL ANIMAL RELATED REQUESTS FROM THE COMMUNITY. THE CCSPCA NETWORKS WITH RESCUE ORGANIZATIONS LOCATED THROUGHOUT CALIFORNIA, AND OREGON. 12 PETS WERE TRANSFERRED TO RESCUE ORGANIZATIONS.
